Ski Cape Smokey effort impresses skiers, investors and community

By the will of great volunteers and the whim of nature Ski Cape Smokey has had two wonderful weekends of downhill skiing.

Abundant snow and freezing temperatures have ensured the recreational facility in Ingonish Beach could be opened to the public. And skiers are responding with over 90 skiers using the runs Saturday, February 12th.

Chair of the Ski Cape Smokey Society, Larry Dauphinee could not be more pleased.

"It has been very successful," he said. "The lodge is open and we are getting lots of compliments."

Ski Cape Smokey, which has been closed for the last four seasons, has had a turbulent recent history. Two seasons of no snow, followed by a lack of operational funding, high power rates, and a fractuous board of directors resulted in a For Sale sign being posted on the icon of Ingonish's winter tourism attraction.

Today a new sense of optimism prevails.

Rumours of new investors are hard to ignore. The show of community solidarity and an excellent work ethic may just turn the tide for any potential investor or purchaser.

Ross Kennedy of Nova Scotia Economic Development says he is very encouraged by what he is seeing at Ski Cape Smokey.

"The leadership of Larry Dauphinee and the volunteers of Ski Cape Smokey Society have taken a very pragmatic approach looking at the assets and making the best use of them for the benefit of the community," he said.

Sydney-Victoria MP Mark Eyking questioned Fisheries Minister Gail Shea on the status of funding to repair breakwaters damaged by storms late last year.

Mr. Eyking believes that money must be made available to repair breakwaters that were damaged in Northern Cape Breton. He would also like to see funding to repair the wharf in Englishtown.

Ports Harbour Authority said, "Our breakwaters are our first line of defense."

Harbour Authorities are anxious to know what kind of funding will be available for repairs.
