County Business Challenge Survey

# Respondents light but data excellent

The Victoria County Business Challenge Surveys are being analyzed. Sustainability Officer, Nona MacDermid has identified some of the key discussion points which she wishes to bring before Municipal Council

The survey which was developed and delivered in mid-late January, wasmailed to all homes and businesses in Victoria County and was available online at the County's website as well as emailed to participants in Strategic Planning forums and to list managers as well as being available on the Bookmobile.

"Unfortunately," Ms. MacDermid said, "Our response rate was low. Although we will try to engage more people every time we use surveys in the future, this survey received some excellent responses that provide feedback we

can use to build a good action plan. We agreed that the people who responded are probably representative of the larger community."

One of the projected outcomes of the survey was to establish a virtual Victoria County Mall but the business response was not sufficient to create one. However, Ms. MacDermid said, "We can use the information provided to start the enhanced Victoria County Directory. I will be looking for other mechanisms to gather the business listing as we proceed."

Ms. MacDermid identified some common responses that could lead to programmes aimed at business and career development. She saw potential for workshops on business organization, strategic planning, succession planning, marketing and media, career transition planning, mentoring, and exporting.

One of the greatest successes of the survey was that 17 business owners agreed to have a Business Retention and Expansion officer from the Cape Breton Regional Development Agency come out to do a field visit and look for ways to help the business grow.

"We originally targeted 5-10 meetings and we nearly doubled the top end of that target," Ms MacDermid said.

The survey identified some intersting opportunities in that 78% to 87% of the business respondents saw opportunities to develop existing or new business activity.

There were a few complaints (2 people were particularly unhappy with the entire survey), but approximately 4-5 people emailed to say that their circumstance didn't seem to fit the survey or they found some aspect confusing.

Victoria County Cap Sites Association (VCCAPS) held a Future Directions Workshop on February 24th at the Gaelic College in St Ann's.

With C@P sites in the communities of Bay St. Lawrence, Iona, Middle River, the libraries in Ingonish and Baddeck, Boularderie and Indian Brook, the organization services most parts of the County. ### Challenges to keep icon alive and well

The stately and venerable centrepiece of Victoria County's many and varied accommodations, the Keltic Lodge in Ingonish, is but one of three provincially owned resorts. Along with Liscombe Lodge and Digby Pines, Keltic Lodge and Spa is in the last year of a four year management agreement with New Castle Hotels and Resorts.

The Province issued a tender for management services for these properties in December of 2010. Four expressions of interest were received. New Castle Hotels and Resorts has reoffered, while Pacrim Hospitality, United Gulf Developments and Cape Breton Resorts also have expressed interest.

Nova Scotia Eonomic Development Minister, Percy Paris said that staff are analyzing the responses and are considering a wide range of options that could include selling the resorts.

Keltic Lodge has one large difference from the other properties in that the Province does not own the land on which it sits. The land is owned by the federal government. This poses a unique situation for the Province. It finds itself in a partnership with the federal government which also owns and
